As per the provision under **Rule 13** of the Information Brochure, the facility to apply for **Institute Level Admissions** on the CAP Portal of the respective courses has been made available to candidates through their individual login.

1. **Institute Level Admissions** include:
 - Seats remaining vacant (if any) after completion of all CAP Rounds
 - Seats under the Institutional Quota
2. Institute Level Admissions shall **commence only after the completion of all CAP Rounds**.
3. The **Institute Level Option Form** is meant for candidates who are **unable to submit their application directly** to the concerned institute.
4. The **Institute Level Option Form link** will be made available in the candidate's login as per the **schedule** on the CAP portal of the respective course.

Please note: This link will not be active during CAP Round Option Form submission days.

5. The **State CET Cell** will forward these applications to the respective institutes **after the completion of CAP Round IV**.
6. The concerned institutes will consider all such applications while preparing the **Inter-Se-Merit List** for Institute Level Admissions.
7. Candidates applying under Institute Level Admissions are advised to **refer to the admission schedule and notices** published by the respective institutes.
8. As Institute Level Admissions are conducted **at the institute level**, candidates must **contact the concerned institutes directly** for further guidance or support.
